#### Opening, introduction and adoption of the agenda

Rosalaura Romeo, Mountain Partnership Secretariat (MPS), welcomed the participants and facilitated the meeting as Hugo Mantilla, the Science and Knowledge Advisory Committee (SKA Committee) Chair could not join.

Nakul Chettri, International Centre for Integrated Mountain Development (ICIMOD), was welcomed as the Vice Chair of the SKA Committee. He expressed his gratitude and is looking forward to collaborating.

The proposed agenda was adopted.

#### Update on the International Year of Glaciers' Preservation 2025

Anil Mishra, United Nations Educational, Scientific and Cultural Organization (UNESCO), presented a background on the International Year of Glaciers' Preservation (IYGP) 2025 and the four task forces that were created to support coordination of the Year. There are upcoming opportunities to collaborate.

Sara Manuelli, MPS, is Task Lead together with Samantha Abear for the IYGP Task Force 1 "Global Campaign for International Year of Glaciers' Preservation 2025" and Miriam Jackson, ICIMOD, is Deputy Lead. Sara highlighted some of Task Force 1's key activities, underlining areas where the SKA Committee's contribution and support would be welcome. These include preparing an outreach strategy for the Year and developing communication, education, and policy materials.

## Planning SKAC's involvement with upcoming UNFCCC SBSTA and COP 29

Adrià Verges Aleix, MPS, shared the main outcomes for mountains from the 28<sup>th</sup> Conference of the Parties to the United Nations Framework Convention on Climate Change (UNFCCC COP28), including: five mentions of mountains in the outcome of the first global stocktake, the approval of a dialogue on mountains; and the declaration of mountains, high-latitude areas, and the cryosphere as a priority thematic work area for 2024 of the Nairobi Work Programme. The Expert Dialogue on Mountains and Climate Change will be held at the 60th session of the UNFCCC Subsidiary Body for Scientific and Technological Advice (SBSTA 60) in June 2024 in Bonn, Germany. Mountains will play a central role in the work of the Nairobi World Programme during 2024.

It was clarified that UNFCCC accreditation is necessary to participate, in person and online.

It was also explained that the International Cryosphere Climate Initiative (ICCI), MRI, the Food and Agriculture Organization of the United Nations (FAO) and the United Nations Environmental Programme (UNEP) contributed to the coordination of the Nairobi Work Programme focal point forum on mountains at UNFCCC COP 28.

The MPS clarified that it contacted the UNFCCC Secretariat regarding the organization of the mountain dialogue and is awaiting a reply. The MPS will share an update with the SKA Committee when available.

#### International Mountain Day 2024 and SKAC involvement/support

Sara Manuelli, MPS, shared that the theme for International Mountain Day (IMD) 2024 will be "Mountain solutions for a sustainable future – innovation, adaptation, youth and beyond." The SKA Committee will soon be asked to provide their input and feedback on the proposed key messages, as they did for IMD 2023.

## Update on policy briefs and publications

Soumyadeep Banerjee, International Organization for Migration (IOM UN Migration), announced that IOM is developing a policy brief with the MPS on migration and climate change.

It was proposed that an outreach strategy on how to promote the briefs be developed. The SKA Committee is encouraged to develop this and build on all relevant occasions (UN days, years, Decades and events at UN Conventions).

Eric Chavez, FAO, provided updates on an upcoming brief for the International Year of Rangelands and Pastoralists 2026. The publication will highlight the importance of grazing animals in mountain areas.

Hanspeter Liniger, Centre for Development and Environment at the University of Bern, informed the SKA Committee that he is preparing a two-page policy brief on pastoralists and suggested another that looks specifically at mountain areas.

Other issues, discussion and conclusions

The MPS will organize a meeting when more information concerning SBSTA 60 and the mountain dialogue is available. Tentatively, the next meeting will take place in May, ahead of SBSTA 60.
