In accordance with FAO Conference Resolution 7/2011, the Council is required to elect six FAO Member Nations to the WFP Executive Board for a term of office of three years (1 January 2016 - 31 December 2018) to fill the following seats:

- 1 seat from List A
- 2 seats from List B
- 1 seat from List C
- 2 seats from List D

1. For purposes of election to the Board, FAO Member Nations are divided into five separate lists (A, B, C, D and E) as shown on the FAO Council Web page under "Additional Information": <http://www.fao.org/about/meetings/council/cl153/documents/en/>
2. The Council is required to elect six members for a term of office expiring on 31 December 2018 to replace the ones whose term ends on 31 December 2015, i.e. Afghanistan (List B), Italy (List D), Mexico (List C), Philippines (List B), Uganda (List A) and United States of America (List D).
3. Outgoing members are eligible for re-election.
4. A nomination form is given in *Appendix A*.
