These are species identification guides which will be used by fishermen and observers onboard vessels operating in the Indian Ocean to help with improving data collection. We have already produced these guides in English and are now in the process of producing these in Portuguese to be distributed to vessels and organisations around Mozambique.

I am writing to you as we have two external organisations who have already and will contribute towards this work and so want their logos to be included on the publications. First of all, projects funded by the EU are provided funding for the production of these guides (budget codes TF.NFITD.TFEU110018036 – 80% and TF.NFITD.TFAA970097099 – 20%).
