BACKGROUND

The Ministry of Agriculture of Kazakhstan (MoA) initiated the process of developing the State Programme 2022–2026 as the implementation of the State Programme of the Agro-Industrial Complex Development in Kazakhstan in 2017–2021 neared completion. According to the rules of the State Planning System of Kazakhstan, the development of the State Programme 2022–2026 had to be preceded by the Concept of the State Programme, which required a comprehensive evaluation of the previous State Programme 2017–2021, including a socioeconomic impact assessment and cost-effectiveness analysis. It also needed to outline the goals, objectives, outcome and output indicators for the designated five-year period (2022–2026), as well as an investment plan indicating the required funds.

Above all, the Concept needed to align with a message by the President of Kazakhstan that emphasized the need to develop agriculture as a competitive sector focusing on food self-sufficiency, improving rural livelihoods, increasing labor productivity and boosting agricultural exports. As a result, MoA sought technical support from the Food and Agriculture Organization of the United Nations (FAO) for the preparation of the Concept and the subsequent development of the State Programme. To this end, the project aimed to support the elaboration of the Package of the State Programme 2022–2026 of Agro-Industrial Development.

IMPACT

Through the elaboration of strategic documents, the project is expected to enable more inclusive and efficient agricultural and food systems and make agriculture, forestry and fisheries more productive and sustainable. This, in turn, is expected to contribute to achieving Sustainable Development Goals 1, 2, 6, 8, 9, 10, 12, 13, 15 and 17.

ACHIEVEMENT OF RESULTS

The project team, in collaboration with MoA staff, developed a working plan and a draft structure for the Concept document. The process involved the participation of 42 international and national experts from analytical organizations and FAO. Fourteen working groups were formed to address priority topics within the Concept's framework, and over 150 proposals from various stakeholders, including sectoral business associations, unions, academia and subordinate entities of the MoA, were carefully considered and discussed by the project team. The team conducted an analysis of the previous State Programme (2017–2021) and the effectiveness of the state support system to identify goals and objectives for the new strategic documents.

Based on FAO's principles of sustainable and inclusive agricultural development, as well as the state planning system of Kazakhstan, the project team developed the structure of the Concept for 2021–2030. The draft was reviewed and refined in agreement with MoA management. The concept emphasized "Balanced Sustainable Development" as a key principle. The project team also prepared recommendations, estimated prospective results and determined the required funding for the implementation of the programme based on the analysis of the previous State Programme, its outcomes and the current state of the agri-food sector. The intermediate results of the elaboration process, including the draft Concept document, were presented to the MoA's management and the Chamber of Entrepreneurs.

Extensive meetings, discussions and consultations involving around 200 participants were organized throughout the process.

Following the State Planning System, the project team developed the structure, goals, objectives and target indicators for the National Project 2021–2025, which focused on 14 subsectors of the agriculture sector. An accompanying calendar plan was also prepared for the project's implementation. Consultations with the MoA's divisions and other national stakeholders were conducted during the development process of the National Project. The team performed a SWOT analysis (strengths, weaknesses, opportunities and threats) of key sectors in agriculture and devised measures to address weaknesses and threats. The project team also organized training sessions using FAO's RuralInvest toolkit to enhance financial and investment awareness among stakeholders.

An Action Plan, an integral part of the Concept for the Development of the Agro-Industrial Complex of the Republic of Kazakhstan for 2021–2030, was elaborated. It included specific actions, reforms, deliverables, completion dates and responsible implementing entities for achieving the Concept's goals and objectives. The Action Plan covered various areas such as crop production, livestock, aquaculture, food processing, organic farming, natural resource management, trade, cooperation development, agricultural science, human capacity development and service provision. The Action Plan, along with the Concept and National Project, was reviewed by the relevant authorities and received approval from the Government of Kazakhstan through official decrees issued on 12 October 2021 and 30 December 2021.

In summary, the project successfully delivered the Concept for the Development of the

Agro-Industrial Complex (2021–2030), the National Project (2021–2025) and the Action plan within the established budget and revised timeframe and were officially endorsed by the Government of Kazakhstan.



IMPLEMENTATION OF WORK PLAN AND BUDGET

As a result of the COVID-19 pandemic and the implementation of a new strategic planning system by the Government of Kazakhstan, an extension of the project timeline was necessary. The project team requested a change in the timeline for the development of the strategic documents. The requested no-cost extension was granted until 30th April 2023. Subsequently, all project activities were carried out within the specified timeframe set by the Government and MoA.

During the implementation of the project, the titles and timing of the strategic documents were modified in accordance with governmental decrees. The final version of the revised titles and dates are as follows:

- Concept for the Development of the Agro-Industrial Complex (AIC) of the Republic of Kazakhstan for 2021–2030;
- ➤ National Project for the Development of the AIC of the Republic of Kazakhstan for 2021–2025; and
- ➤ Action plan for the implementation of the Concept for 2021–2030.

FOLLOW-UP FOR GOVERNMENT ATTENTION

Recommendations have been provided in the Concept of Development of Agriculture,

Key recommendations include the improvement of national legislation in the area of production and circulation of organic products, introduction of an effective planning and monitoring system of state support and land resources management.

SUSTAINABILITY

1. Capacity development

The sustainability of the project outcome and its alignment with relevant policies and the legal framework are key considerations. The project team, along with the working group, devised specific measures for each subsector of the agrifood industry that aim to improve the regulatory and legal framework, thereby enhancing the sustainability of the agricultural sector. As part of this effort, new legislative pieces are expected, and amendments will be proposed for at least seven existing laws. Some of the laws that will undergo revision include the State Regulation of the Development of the Agricultural Sector and Rural Areas, Livestock Breeding and Pasture Land and the Order of the Ministry of Agriculture on Subsidizing Compensation of Costs Incurred by Agricultural Sector Entities in Investment Activities.

In terms of organizational structures, the project successfully embedded itself within the MoA and other relevant institutional bodies. This integration strengthened the capacity of these organizations to plan and implement sustainable agricultural policies focusing on subsectoral planning, national competitive advantages and inclusive agricultural development.

The positive impact of these efforts extends to the development of rural areas and the improvement of livelihoods, particularly for the rural population.

The project's sustainability was also fostered through partnerships and alliances. Close collaboration was maintained with MoA and its subordinate structures, sectoral ministries, academia, sectoral associations, unions, businesses, agricultural producer associations and non-governmental organisations whose roles and responsibilities were clearly defined in the endorsed documents. These entities actively contributed to the project, offering over 150 proposals for consideration.

2. Gender equality

Ensuring meeting the needs and priorities of both women and men beneficiaries and stakeholders was a key consideration throughout the project. From the design stage onwards, equitable gender involvement was pursued. The project also strived to ensure equitable benefits for women and men. Approximately 21 percent of the project meetings' participants, totaling around 220 individuals, were women, demonstrating a commitment to inclusive representation. Also, FAO organized two five-day trainings on the FAO's RuralInvest toolkit, where more than 50 percent of the participants were women.

To further reinforce gender equality, the project integrated this principle into its three resulting strategic documents including the Concept, the National Project and the Action Plan. The endorsement of these elaborations by the Government adds weight and effectiveness to the implementation of gender equality measures.

3. Environmental sustainability

The project made significant efforts to integrate environmental sustainability into its activities. By prioritizing "green" technology and sustainable agricultural production, the project aimed to enhance the quality of life while ensuring high environmental standards. Concrete measures were implemented to minimize environmental impact, such as the effective management of natural resources and the adoption of resource-saving technologies. The project's commitment to environmental sustainability is evident in the Concept for 2021–2030 and the National Project 2021–2025 documents.

These documents highlight the project's objectives, including the development of new infrastructure and the upgrading of existing infrastructure to support sustainable practices. Additionally, the project aligned with Kazakhstan's commitment to various global UN conventions, particularly in mitigating climate change.

4. Human Rights-based Approach (HRBA) – in particular Right to Food and Decent Work

The project has actively contributed to the promotion and achievement of human rights, implementing the Right to Food Guidelines adopted by FAO in 2004 and creating employment and entrepreneurship opportunities for targeted groups, particularly rural youth and women. The project will contribute to food self-sufficiency, enhancing overall food security and promoting inclusive and sustainable agricultural development, as outlined in the adopted strategic documents, and also contributed to the policy to provide for stakeholder's access to food, natural resources, markets, finance and legislation. The project also proposed the development of agricultural cooperation, as outlined in the Concept for 2021-2030 and the National Project for 2021–2025, which was a central objective. By fostering gainful employment, the project aimed to enhance economic prospects and empower these groups within rural communities. Further, with 43 percent of the total population consisting of rural communities, the project's impact on labour conditions in rural areas are considered significant. The comprehensive development of social capital was a key principle underlying the project and its resulting strategic documents, which emphasizes the importance of improving labour conditions.

5. Technological sustainability

The project made significant contributions to the development of local knowledge, capacity, resources and good practices in Kazakhstan. It strengthened the national capacity for planning and implementing sustainable and inclusive agricultural policies. One notable achievement was the RuralInvest training conducted as part of the project. This training enhanced the financial and investment awareness of farmers and other stakeholders, equipping them with the skills necessary for formulating investment projects. Representatives from credit associations participated in the training, improving their ability to assess and score investment projects. Additionally, the involvement of agrarian universities expanded the training capacity of the toolkit, further enhancing local knowledge and expertise.

In terms of stakeholders' and beneficiaries' capacity to continue project activities without further technical assistance, the project's key policy documents, including the Concept, National Project, and Action Plan, were jointly elaborated with MoA.

These documents received government endorsement through decrees, indicating their long-term validity until 2031. As a result, no additional technical assistance is required for their implementation. Through the FAO–Kazakhstan Partnership Programme (FKPP), FAO could provide additional support to MoA and its stakeholders through projects in the future.

6. Economic sustainability

The project successfully secured additional financial resources for the implementation of the National Project. The approved Action Plan specifies that the national budget will allocate a substantial amount of USD 1.6 billion. This allocation of funds demonstrates a significant commitment towards advancing the goals and objectives of the project, ensuring its economic sustainability.
