EXECUTIVE SUMMARY

- The Comptroller and Auditor General of India presents a proposal for a second increase to the original annual remuneration of USD 385,000 payable for the External Auditor. The increase amounts to USD 15,400 per annum, effective from April 2014, in order to cover an increase in costs, as provided for in the contract. As a result, the total annual fee is increased to USD 415,800.

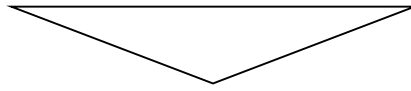

DRAFT DECISION*



The Board approves a second increase of 4 percent of the original annual remuneration of USD 385,000 payable to the External Auditor, involving a total increase of USD 15,400, on grounds of an increase in daily subsistence allowance, staff costs and airfare. As a result, the total annual fee is increased to USD 415,800, applicable from April 2014.

Introduction

1. This document presents the External Auditor's proposal for the increase in audit fee amounting to USD 15,400 per annum from April 2014 onwards.

Background

2. The Comptroller and Auditor General of India has been appointed by the Executive Board as the External Auditor for WFP for the term 1 July 2010 to 30 June 2016 at a total annual remuneration of USD 385,000.
3. In view of net increase of 13 percent in the cost of audit under components of daily subsistence allowance (DSA), staff costs and airfare since November 2009 (time of bid), the Executive Board had allowed the External Auditor an increase of 4 percent in audit fee amounting to USD 15,400 per annum from April 2012 (WFP/EB.2/2012/5-B/1). Accordingly, the annual fee is currently USD 400,400 per annum from April 2012.

Proposal

4. The Comptroller and Auditor General of India has proposed further increase of 4 percent of its original annual remuneration of USD 385,000 with effect from April 2014, i.e., a total increase of 8 percent over the original annual remuneration of USD 385,000 in view of the following:
 - There has been a net increase of 27 percent in the audit cost under components of DSA, staff costs and airfare at Rome over the last four years. The DSA rates used were the United Nations rates set by the International Civil Service Commission, airfare costs were standard economy class tickets of various European airlines, and the staff costs were the salaries and allowances of visiting audit team members and the Director of External Audit, Rome. The percent increase in the various costs is detailed in Table 1 of Annexure A. The increase in USD amounts under the various heads is also depicted in Table 2 of the Annexure A.
 - The agreement with WFP under Article 6 (d) – Remuneration, and the Board Document WFP/EB.A/2010/6-B/1 para 16 enumerate that the External Auditor may request limited increases in relation to services to be provided after the first year of the term of the agreement, due to variations in the cost of air travel, staff costs and rates of daily subsistence allowance, which shall not, over the terms of its office, exceed a cumulative total of 8 percent of the total annual remuneration.
 - The increase is not for any additional tasks or work outside the original scope, which as per the contract/Board document would be the object of discussion with WFP.
5. In view of the above justifications, we seek the Executive Board's approval for a 4 percent increase in audit fee for the External Auditor, involving an increase of USD 15,400 from April 2014 onwards. The total annual fee will be increased to USD 415,800 from USD 400,400, being claimed from April 2012.
