Status of Current Assessments and Arrears as at 29 June 2020

EXECUTIVE SUMMARY

The document presents the Status of Contributions to the Regular Programme as at 29 June 2020 showing receipts of current assessments and arrears presented as follows:

The main points highlighted are:

- 1) As at 29 June 2020, 77 Member Nations had paid their contributions in full and 117 Member Nations still owed current assessments (in full or in part), totalling USD 110.67 million and EUR 88.87 million (Appendix A/Appendix B).
- 2) The collection rate for current assessments was 56.54 percent.
- 3) Seventy (70) Member Nations still owed arrears totalling USD 52.42 million and EUR 46.85 million (Appendix B/Appendix C) as at 29 June 2020 and which was equivalent to 21.9 percent of current assessments.
- 4) Twenty-Four (24) Member Nations had arrears in such amounts as to jeopardize their right to vote in accordance with Article III.4 of the Constitution (Appendix G).

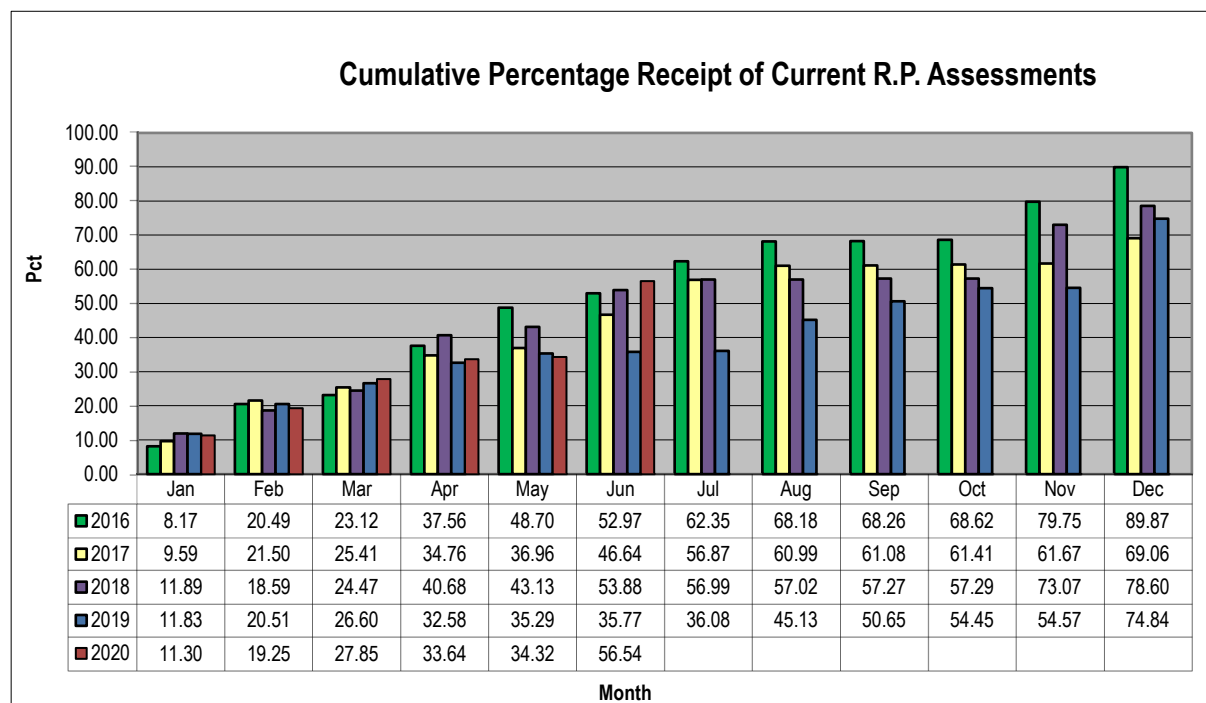

**ADDITIONAL INFORMATION REGARDING ARREARS DUE AT
29 June 2020**

- The total arrears at 29 June 2020 was USD 52.42 million and EUR 46.85 million (Appendix B/Appendix C) equivalent to 21.9 percent of current assessments.
- Nine Member Nations had arrears in excess of USD 1 million: Argentina, Brazil, Colombia, Iran (Islamic Republic of), Libya, Nigeria, Turkmenistan, United States of America and Venezuela (Bolivarian Republic of)). In addition, USD 8.4 million remains outstanding from the former Socialist Federal Republic of Yugoslavia. In line with the established practice of FAO, the issue of the arrears accumulated by the Former Socialist Federal Republic of Yugoslavia will be dealt with by taking into account the final decision (still pending) taken on the matter at the United Nations (Appendix C).
- Arrears exceeding USD 1 million accounted for 95.82 percent of the total arrears due.
- Twenty-Four Member Nations had arrears in such amounts as to jeopardize their right to vote in accordance with Article III.4 of the Constitution (Appendix G).
- The total of 70 Member Nations in arrears at 29 June 2020 was higher than the figure of 60 as at 29 June 2019.
