Feedback to Pakistan on the level of implementation of IOTC Conservation and Management Measures identified by the CoC10 in 2013.

Feedback: With regards to the level of compliance by Pakistan to the decisions of the Commission, the Compliance Committee noted certain issues that required attention. These concerns were communicated to Pakistan by the Chair of the Commission in a letter dated 10th May 2013.

<ul style="list-style-type: none">• IOTC Implementation Report (Article X of the IOTC Agreement) and IOTC Compliance Questionnaire: Noting that Pakistan has not provided the two reports, the CoC URGED Pakistan to make special effort to provide these reports as soon as possible.
<ul style="list-style-type: none">• Resolution 01/02 (Management standards): Noting that Pakistan has not provided information on management standards according to the requirements of the resolution, the CoC URGED Pakistan to make further efforts to improve the situation for the following year.
<ul style="list-style-type: none">• Resolution 10/02 (Minimum reporting requirements): Noting Pakistan has not reported catch and effort data. The CoC URGED Pakistan to submit the data as soon as possible.
<ul style="list-style-type: none">• Resolution 12/09 (Thresher sharks): Noting that Pakistan has not transposed the ban on thresher sharks into domestic legislation, the CoC URGED Pakistan to continue its efforts and to provide a copy of the regulation, when available.
<ul style="list-style-type: none">• Resolution 12/12 (ban large scale driftnet): Noting that Pakistan has not transposed the ban on large scale driftnet into domestic legislation, the CoC URGED Pakistan to continue its efforts and to provide a copy of the regulation, when available.
<ul style="list-style-type: none">• Resolution 12/11 (Baseline capacities): Noting that Pakistan has not provided its baseline capacities for tropical tunas and/or swordfish and albacore, as required by this resolution, the CoC URGED Pakistan to submit the data as soon as possible.
<ul style="list-style-type: none">• Response to the letter of feedback: Noting that Pakistan has not provided a response to the letter of feedback, the CoC ENCOURAGED Pakistan to provide a response to the letter of feedback of 2012.

Response: No response to the letter of the Chair of the Commission was provided by Pakistan.

Current issues on the level of implementation by Pakistan of IOTC Conservation and Management Measures identified for discussion in the CoC11 in 2014.

Having reviewed the 2014 Compliance Report for Pakistan, the Chair of the Compliance Committee has identified the following significant non-compliance issues for discussion.
