# CONFERENCE

## Thirty-ninth Session

Rome, 6-13 June 2015

### Second Report of the Credentials Committee

1. The Credentials Committee of the Thirty-ninth Session of the Conference held three meetings on 27 May, 6 June and 11 June 2015, to examine the credentials received. The Committee elected Ms Daniela Rotondaro (San Marino), as its Chairperson, and Mr Rasmi Mahmoud (Oman), as its Vice-Chairperson.
2. The Credentials Committee noted Rule III of the General Rules of the Organization on “delegations and credentials”, as well as the practice and criteria followed by the Organization with respect to the acceptance of credentials, in accordance with the prevailing practice in the United Nations System on the matter. The Credentials Committee also noted that the Council, at its 148<sup>th</sup> Session held in December 2013, endorsed proposals to further streamline the overall process of acceptance of credentials, including through increased reliance on credentials issued by Permanent Representatives accredited to the Organization, taking into account the reduction in the duration of sessions of the Conference, as well as the practice of other organizations of the United Nations System.
3. The Credentials Committee reviewed the credentials or information received regarding the composition of delegations shown in *Annex I*. One Member informed the Director-General of its intention not to attend the Conference and 3 Members have not provided any information on their participation or representation in the Conference session.
4. The Committee recommended to the Conference that the credentials of the delegations listed in *Annex* to this First Report be accepted, on the understanding that formal credentials of Members and Associate Members, in original form, would be communicated to the Director-General in due course, and that all delegations be authorized to participate fully in the Conference session. The list reflects the situation as of 11 June 2015.
