PROVISIONAL AGENDA

1. Adoption of the Agenda and Timetable for the Session

In order to facilitate the negotiations under agenda item 2, the Commission may decide, as on past occasions, to establish *Ad Hoc* Working Groups, as well as to convene a limited number of parallel meetings of these Working Groups, bureau meetings and night sessions. The secretariat has accordingly made arrangements for interpretation that provide the Commission with considerable flexibility.

2. Continuation of negotiations for the revision of the International Undertaking on Plant Genetic Resources

Conference Resolution 7/93 requested the Director-General to provide for negotiations among governments, in the Commission on Genetic Resources for Food and Agriculture,¹ for the adaptation of the International Undertaking on Plant Genetic Resources, in harmony with the Convention on Biological Diversity.² The Resolution "urges that the process be carried out through the regular and extraordinary sessions of the Commission on Plant Genetic Resources".

These negotiations, which began in November 1994, most recently took place during the Commission's Fourth Extraordinary Session (1-5 December 1997). On that occasion, the Commission "considered that considerable progress had been made during the Session, which had been characterized by a very positive spirit on the part of all delegations and all regions. It stressed the need of building upon this spirit, maintaining momentum, and moving ahead in a structured and productive manner".

² While the Convention on Biological Diversity covers all kinds of biological diversity, the scope of the Undertaking is limited to plant genetic resources for food and agriculture.

At the request of the Chairman of the Commission, the Consolidated Negotiating Text resulting from the Commission's Fourth Extraordinary Session will form the basis of the negotiations under this item.

The Fourth Extraordinary Session of the Commission requested the International Plant Genetic Resources Institute (IPGRI), in consultation with the Commission's Secretariat, to prepare a study of the technical aspects to be considered in reviewing and further developing the *Tentative list of crops* annexed to Art. 11 of the Consolidated Negotiating Text, which is available as Document CGRFA-Ex5/98/Inf.1. In order to facilitate the work of the Commission, some illustrative additional information on the crops in the *Tentative list* is available as Document CGRFA-Ex5/98/Inf.1/Annex. The Fourth Extraordinary Session also requested the FAO Legal Office to assemble an anthology of definitions used in relevant international agreements that might be pertinent to the revision of the Undertaking, available as Document CGRFA-Ex5/98/Inf.2.

In addition, a number of documents dealing with technical, economic, legal and institutional matters of relevance in the revision of the International Undertaking, as well as the Fourth Negotiating Draft of the International Undertaking, which have already been presented to the Commission, but not yet fully discussed, will also be available for information³. The Reports of the Seventh Regular and Fourth Extraordinary Sessions of the Commission are also available.
